Systech was an early pioneer in the waste disposal industry, and we continue to adapt, innovate and evolve to meet customer needs through environmentally friendly methods.

Today, Systech, and its sister company Geocycle, co-process by-products and waste materials at 22 cement kilns across North America. Both are affiliates of LafargeHolcim, a world leader in the building materials industry. Our hazardous waste network includes cement plants in Paulding OH, Tulsa OK, Holly Hill SC, and processing operations in Fredonia KS and Artesia MS.
